Dear Parkinson's community,

When Congress passed yet another continuing resolution earlier this fall, we told you we would have a difficult road ahead in securing more funding for medical research. We told you about the political obstacles and the limited amount of time and opportunities because of the midterm elections. We encouraged you to reach out and share your stories with your Members of Congress.

We told you just how much your voice matters – and you responded time and again.

Since late September, more than 4,000 individual messages were sent to Members of Congress from the Parkinson's community on the importance of strengthening and preserving federal spending for medical research. Due in no small part to your efforts, combined with those from medical research advocates across the country, Congress has completed work on a spending bill that fully funds or increases funding for the National Institutes of Health, the Department of Defense Parkinson's research program, and the Food and Drug Administration for the remainder of Fiscal Year 2015.

While the legislation is not perfect and the increases are modest, Congressional leaders have made it clear that federal medical research funding is a priority – and as a result we have new opportunities to seek additional funding in the coming year that would not have been possible without your advocacy.

Thank you.

As 2014 comes to a close, we're already beginning to make plans for the 114th Congress, where the 21st Century Cures Initiative and repealing the Medicare therapy caps will likely be top issues in the first quarter of next year. We'll also continue to push for more robust research funding and work to ensure that people with Parkinson's have access to the best care possible.

Thank you again for your dedication and all that you do on behalf of the Parkinson's community. We look forward to working with you to accomplish even more in 2015.
